OEB Proceedings:

The Consumers Council of Canada has participated in many proceedings as an intervenor over the last 24 months. We have not been denied intervenor status.

Issues:

The Consumers Council of Canada is materially impacted by the application as it represents residential consumers of electricity and natural gas. The outcome of the proceeding will affect the rates that customers pay for electricity and natural gas.

The Council is interested in the methodology for determining the values of the cost of capital parameters and deemed capital structure to be used to set rates for electricity transmitters, electricity distributors, natural gas utilities and Ontario Power Generation Inc. The Council is also interested in the methodology for determining the OEB's prescribed interest rates and matters related to the OEB's Cloud Computing Deferral Account.

Hearings:

The Council supports the OEB's proposal to hold an oral hearing.

Evidence:
