Charges – Redaction of Non-Relevant Information in Interrogatory

On March 11, 2024, Toronto Hydro filed its responses to interrogatories as part of this proceeding in accordance with Procedural Order No. 1. Interrogatory 1A-CCC-1 requested, among other items, all materials provided to Toronto Hydro's Board of Directors with respect to this application.

In response to Interrogatory 1A-CCC-1, Toronto Hydro has produced a document titled "Customer Engagement & Rate Application Update" (1A-CCC-1 Appendix D). Pursuant to the OEB's [Practice Direction on Confidential Filings](#), Toronto Hydro has proposed to redact pages 2 to 13 and pages 28 to 32 of 1A-CCC-1 Appendix D on the basis that the pages are not relevant because they do not relate to the application and contain information on more general topics.

The OEB requires further information regarding these proposed redactions:

- a) Please confirm that no aspects of the proposed redactions were causative, in any way, to the proposals in the application.

- b) Are any of the proposed redactions proprietary information to Toronto Hydro, or a third party? If so, which pages?
- c) For the proposed redactions to pages 28 to 32, please indicate if the source information is publicly available. Please explain.
- d) As the proposed redactions are described as “not relevant” to the application, please confirm the associated cost of this work was not proposed for recovery by consumers. In other words, please indicate whether 100% of the cost for preparing 1A-CCC-1 Appendix D was, or was not, proposed for recovery in the application.

Please submit a response to this letter by **March 28, 2024**. The OEB will consider the information provided by Toronto Hydro in its determination of whether the pages proposed to be redacted from 1A-CCC-1 Appendix D are relevant to the proceeding.
