Issues:

CME's members are ratepayers of both electricity utilities (generation, transmission and distribution) as well as natural gas. Accordingly, the cost of capital parameters set by the Board will have a material impact on the rates paid by CME's members for these services.

Policy Interests:

N/A CME's interest is a ratepayer related.

Hearings:

CME submits that an oral hearing is appropriate for this proceeding.

Evidence:

It is not clear at this time whether CME will file evidence. It will likely work with other intervenors to ensure that the Board has the appropriate evidence before it to make a reasonable and appropriate determination in this proceeding.

Coordination with Other Intervenors:

CME is a frequent intervenor in OEB cases. CME will at all times, communicate with other intervenors so as to reduce duplication of effort as much as possible, with respect to expert evidence, interrogatories, cross examination, or submissions.

Cost Awards:

CME hereby applies for cost award eligibility in this proceeding. CME is eligible for a cost award as CME primarily represents the direct interests of consumers/ratepayers in relation to electricity and natural gas, pursuant to section 3.03(a) of the Board's Practice Direction on Cost Award, April 1, 2023. CME regularly intervenes in proceedings before the Board and is routinely granted cost award eligibility.
