Don Richardson, Ph.D.

C.V. – Ontario Energy Board Experience

2024

Dr. Richardson has over 30 years of experience as a skilled facilitator supporting project implementation, impact assessments and building agreements between energy, infrastructure and resource management project proponents, community/non-governmental organizations, government agencies, and rural/Indigenous communities. He fosters constructive engagement to create shared value between communities and infrastructure proponents.

Dr. Richardson has appeared as a witness several times in various regulatory proceedings and has presented before the Ontario Energy Board on a number of occasions. As a consultant to Anwaatin Inc., he is an experienced intervenor before the Board, representing the interest of Indigenous communities. Dr. Richardson has a high level of familiarity with the Ontario Energy Board's practice directions, rules of practice and procedure, filing requirements and related administrative guidance.

On behalf of Anwaatin Inc., the Three Fires Group, Minogi Corp., and other parties Dr. Richardson has been active in representing various Indigenous interests before the Ontario Energy Board in a number of electricity and natural gas proceedings and consultations. Dr. Richardson has assisted Anwaatin and its First Nation clients in being a pioneer of distributed energy resource (DERs) initiatives before the Board and helped to achieve the first landed grid energy storage projects to improve poor electricity reliability in vulnerable Indigenous communities (see EB-2017-0355, Decision and Order, August 23, 2018 and EB-2017-0049, Decision and Order, March 7, 2019).

Dr. Richardson served as the represent of Anwaatin in the Ontario Energy Board's Framework for Energy Innovation: Distributed Resources and Utility Incentives consultation (Board File No.: EB-2021-0118), and was recently appointed as a representative of Anwaatin to the Reliability and Power Quality Working Group (Board File No.: EB-2021-0307). He is or was an active participant in, among others, the following Board proceedings: EB-2021-0002; EB-2021-0004; EB-2020-0194; EB-2020-0212; and EB-2020-0106. Dr. Richardson also recently served as a member of the Ontario Energy Board's Adjudicative Modernization Committee which considers best practices and approaches to adjudication that enhance the OEB's efficiency and effectiveness in delivering on its mandate to regulate Ontario's energy sector as required under provincial legislation. Dr. Richardson is also a member of the Independent Electricity System Operator's Transmission-Distribution System Working Group (TWDG).

Dr. Richardson has experience with several large scale and small scale energy infrastructure development projects, and energy regulatory and policy matters, working on behalf of First Nation governments across Ontario. He has extensive experience navigating the deployment, use, and integration of DERs as well alleviating energy poverty in and around Indigenous communities. He is also a recipient of the Canadian Urban Institute's Brownie Award recognizing outstanding achievement in building and maintaining effective working partnerships with professionals, the local community and others involved in Brownfields redevelopment, and a Consulting Engineers of Ontario, Canada Award for Indigenous Traditional Knowledge achievements.
