**Re: uTrack Energy (uTrack)
Application for a Unit Sub-Metering Licence
File: EB-2024-0122**

The Ontario Energy Board (OEB) received uTrack's application for an unit sub-metering licence on March 18, 2024. The OEB has assigned file number EB-2024-0122 to the application.

Upon preliminary review of the application, OEB staff has determined it to be incomplete. Accordingly, please be advised that the application cannot be processed until the following missing information is filed:

1. Section 9(a): Corporate Organization:

Please submit a corporate organization chart that outlines the applicant, its parent, and any associated affiliates of the applicant.

2. Section 13(b): Compliance with Legal and Regulatory Obligations:

The applicant states that its "application is for a transfer of licence from the parent company, Edgecom Energy and is already providing these services."

Does Edgecom Energy intend on carrying out unit sub-metering services in the future? If yes, please explain what the "transfer of licence" means.

If no, Edgecom Energy is required to submit a request to cancel its unit sub-metering licence (ES-2020-0099) to the Office of the Registrar and include a reason for the cancellation.

Section 57(c.1) of the *Ontario Energy Board Act, 1998* states that no person is permitted to engage in unit sub-metering without a licence.

According to section 13(b), the applicant states that it is already providing unit sub-metering services. How long has uTrack Energy been engaging in unit sub-metering activities without a licence? Please indicate when the applicant had begun engaging in unit sub-metering activities.

The OEB will process the application after the noted information is filed with the Registrar at registrar@oeb.ca. Please submit both an electronic Word version and an electronically signed, searchable PDF. If the above information is not filed within 30 days of the date of this letter, the OEB may close the file for this application.

Please note, uTrack is responsible for ensuring that the documents it files with the OEB, such as its evidence, responses to interrogatories and any other supporting documentation, do not include personal information (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's *Rules of Practice and Procedure*.
