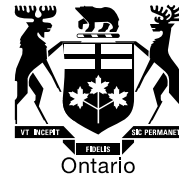

**Re: Application for Electricity Generator Licence
Board File Number EB-2007-0676**

This letter acknowledges receipt of your application for an electricity generator licence. The Board has assigned File Number EB-2007-0676 to this matter. Please refer to this number in all future correspondence to the Board regarding this matter.

Your application as filed is incorrect and cannot be processed until the following has been filed:

Reapply by using the Standard Offer Program application and include a complete address for the new generation facility.

In your application, you stated that, "the Trent Rapids Power Corporation is a 50/50 partnership between Peterborough Utilities Inc. and Shaman Power Development." As Peterborough Utilities Inc. is an affiliate of Peterborough Distribution Inc., section 80 of the *Ontario Energy Board Act* applies.

Section 80 provides that,

"No transmitter or distributor or affiliate of a transmitter or distributor shall acquire an interest in a generation facility in Ontario, construct a generation facility in Ontario or purchase shares of a corporation that owns a generation facility in Ontario unless it has first given notice of its proposal to do so to the Board and the Board,

- a) has not issued a notice of review of the proposal within 60 days of the filing of the notice; or
- b) has approved the proposal under section 82.”

Peterborough Distribution Inc. is required to file a section 80 application. For your reference, an electronic copy of the section 80 application is attached.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
