Patrick Boileau HBA, MSRE President – North Vista Advisors

Patrick grew up in Sudbury and received his Honours Degree in Business Administration from Wilfrid Laurier University. He worked at Brookfield Asset Management for several years, including two years in Brazil with the company's real estate and power development groups.

Patrick then completed his master's degree in real estate finance at the University of Florida.

Patrick spent several years in Toronto working in the real estate, and strategic investments groups at OMERS, a \$60 billion pension fund for Ontario municipal employees. Patrick was involved with the acquisitions of commercial properties, an engineering company, and two airports in Costa Rica. Patrick managed several interests for the pension fund including a significant holding in Porter Airlines.

Patrick also represented OMERS as a board member for ADC & HAS, an airport investment and management company based in Houston. The company completed several acquisitions and had a mandate to make \$150 million in airport investments throughout Latin America over a five-year period.

Patrick moved to Thunder Bay in 2010 to advise Goldcorp on various energy supply and infrastructure projects in Northern Ontario. He advised Goldcorp on the Red Lake Gas Pipeline Project, a \$40 million, 104 km pipeline to bring natural gas service to the residents, businesses, and industries of Red Lake. The project was commissioned in October 2012.

Patrick was also a founding Board Member for Wataynikaneyap Power and continues to act as a consultant to the 24 First Nation partnership. This project is currently being developed by a 24 First Nation partnership with Fortis Inc. The \$1.8 billion project is now under construction, with an expected completion in mid 2024. Patrick was also the project manager on the \$60 million Pikangikum Powerline Project, completed in 2018.
