**Re: Enbridge Gas Inc. (“EGI”)
2024 Rebasing Application
Board File Number: EB-2022-0200**

We are counsel to the Association of Power Producers of Ontario (“APPrO”) in the above-noted proceeding. On April 16, 2024, the Ontario Energy Board (“OEB”) issued Procedural Order No. 8 directing cost eligible intervenors to file their cost claims with the OEB. APPrO’s cost claim has been prepared and filed through the OEB’s online cost claim filing system in accordance with section 10 of the OEB Practice Direction on Cost Awards.

APPrO participated reasonably in the process by focusing its involvement in the proceeding to issues directly relevant to its members. This ensure that its participation in the process would not unduly repetitive and was focused on relevant and material issues. This was evident in the interim cost award where APPrO’s claimed costs were 5th lowest out of the 14 interveners.

APPrO’s submissions contributed to a better understanding by the OEB of the issues in the process. One of APPrO’s central arguments was that the OEB panel did not have enough information from generators, transmitters and distributors about whether the IESO would be able to meet Ontario’s energy demands. This was an influential point in Commissioner Duff’s dissent. Finally, APPrO did not engage in conduct that tended to lengthen the process unnecessarily or engage in any inappropriate or irresponsible conduct.

APPrO was awarded \$69,661.11 in costs on August 18, 2023. The costs claimed in this application of \$87,172.72 are incremental to those prior costs.
