NOTICE OF APPLICATION

For An Electricity Transmitter Licence

The Ontario Energy Board has received from Five Nations Energy Inc. on March 31, 2003 an application for an electricity transmitter licence, Board file number ET-2003-0074.

This application concerns the electricity transmission service to the First Nations communities in the James Bay area of Northern Ontario, including Fort Albany, Attawapiskat and Kashechewan.

Following a consideration of this application, the Director of Licensing will issue a Notice of Proposal to issue or refuse a licence. A copy of this Notice of Proposal will be sent only to those parties who have indicated their interest in the Application by responding to this Notice.

If you wish to receive the Director of Licensing's Notice of Proposal and be entitled to make written submissions on it, you must now write a letter to the Board Secretary at the address set out below.

Your letter must quote the file number of the application, clearly state your name and address, and be received by the Board Secretary within fourteen (14) calendar days of the publication of this Notice. Your letter should indicate the nature of your interest in the Application.


