**Application to amend licence EI-2013-0066**

**PROCEDURAL ORDER NO. 1**

**May 14, 2024**

The Independent Electricity System Operator (IESO) filed an application with the Ontario Energy Board (OEB) on March 25, 2024 under section 74 (1)(b) of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15 (Schedule B), seeking approval to update certain sections of its licence to reflect the Market Renewal Program (Application).

A Notice of Hearing was issued on April 26, 2024. Each of Association of Power Producers of Ontario (APPrO), and Power Advisory (representing jointly): Canadian Renewable Energy Association, Energy Storage Canada and Ontario Waterpower Association (REASCWA), applied for intervenor status and cost eligibility.

No objection was received from IESO.

APPrO and REASCWA are approved as intervenors and eligible to apply for an award of costs under the OEB's [Practice Direction on Cost Awards](#). The list of parties in this proceeding is attached as Schedule A to this Procedural Order.

Being eligible to apply for recovery of costs is not a guarantee of recovery of any costs claimed. Cost awards are made by way of OEB order at the end of a hearing.

At this time, provision is being made for submissions and reply submissions. The scope of the submissions is limited to the proposed wording changes in the draft license amendments that were filed by the IESO in the Application.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

**IT IS THEREFORE ORDERED THAT:**

1. Any written submissions by OEB staff and intervenors shall be filed with the OEB and served on all other parties by **May 29, 2024**.
2. The IESO may file a written reply submission with the OEB and serve it on intervenors by **June 10, 2024**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
