However, as per the Independent Electricity System Operator's (IESO) Expedited Long-Term RFP (E-LT1 RFP) Final Results and the IESO Active Contracted Generated List, Walker BESS 4 Limited Partnership has been listed, and not Walker BESS 4 Inc. In light of this, please clarify and/or provide the following information:
  - (a) The relationship between Walker BESS 4 Inc. and Walker BESS 4 Limited Partnership;
  - (b) The reason for filing the application under the name of Walker BESS 4 Inc., and not Walker BESS 4 Limited Partnership, when Walker BESS 4 Limited

(c) Please share with us copies of the contract(s) executed by Walker BESS 4 Inc., with the IESO, for E-LT1.
