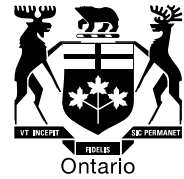

**LETTER OF DIRECTION**

Dear Mr. MacDonald:

**Re: Hydro One Networks Inc. – 2009 and 2010 Electricity Transmission Rates  
Application Board File Number EB-2008-0272**

The Ontario Energy Board has now issued its Notice of Application with respect to your transmission rate application.

You are directed:

1. To arrange immediately for the enclosed English version of the Notice, headed with the Ontario government logo and the words "Ontario Energy Board", to be published in one edition of each of the English language newspapers as set out in Attachment "A" to this letter in or servicing Hydro One Networks' service area;
2. To arrange immediately for the enclosed French versions of the Notice headed with the Ontario Government logo and the words "Commission de l'énergie de l'Ontario", to be published in one edition of each of the French language newspapers as set out in Attachment "A" to this letter, in or servicing Hydro One Networks' service area (**Note:** Please make it clear that invoices regarding publication are not to be sent to the Board);
3. To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on Electricity Distributors and other transmission customers served by Hydro One Networks Transmission; on all licenced

transmitters in Ontario, and on all intervenors of record in the previous transmission rate application proceeding EB-2006-0501;

4. To file with the Board an affidavit proving publication and service of the Notice immediately thereafter;
5. To make a copy of the application and evidence available for public review at Hydro One Networks' offices in Toronto, Markham, Barrie, Peterborough, Sudbury, Ottawa, Dundas, Beachville, and Thunder Bay; at the following addresses:
