LETTER OF DIRECTION

Dear Ms. MacKinnon:

Re: Hydro One Networks Inc. (Hydro One) Leave to Construct Application – St. Clair Transmission Line Project Ontario Energy Board File Number EB-2024-0155

The Ontario Energy Board (OEB) has now issued its Notice of Hearing for Hydro One's Leave to Construct Application – St. Clair Transmission Line Project (Notice). The Notice will be published by the OEB, in accordance with directions to the OEB's media agent which were copied to you. Please note that you must comply with the directions in paragraphs 1 to 3 below prior to **July 4, 2024**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at registrar@oeb.ca.

You are directed:

- 1. To conduct a search of title forthwith, sufficient to determine the current registered property owners and encumbrancers with lands or interest in the lands directly affected by the proposed construction of the transmission line and related facilities.
- 2. No later than the date the Notice is posted on Hydro One's website in accordance with paragraph 3, to arrange for the service of the enclosed Notice, in the exact form accompanying this letter and the application and the evidence, directly on each of the following:
 - a. All property owners and encumbrancers with lands or interest in lands identified in the search of title referred to in paragraph 1

- b. All electricity distributors in whose service areas the proposed transmission line and related facilities will be located
- c. All generators impacted by the proposed transmission line and related facilities
- d. All transmission customers of Hydro One impacted by the proposed transmission line and related facilities
- e. All owners and operators of rail lines, telecommunications (e.g., telephone) or other utilities along or crossing the route and location for the proposed transmission line and related facilities will connect
- f. St. Clair Township
- g. County of Lambton
- h. Municipality of Chatham-Kent
- i. All indigenous communities that have been consulted or with lands or interest in the lands directly affected by the proposed upgrade and construction of the transmission line and related facilities
- j. The following government ministries and agencies:
 - i. Ministry of Energy
 - ii. Ministry of Infrastructure
 - iii. Ministry of Environment, Conservation and Parks
 - iv. Ministry of Northern Development, Mines
 - v. Ministry of Natural Resources and Forestry
 - vi. Ministry of Indigenous Affairs
 - vii. Ministry of Transportation
 - viii. Ministry of Municipal Affairs and Housing
 - ix. Ministry of Tourism, Culture and Sport
 - x. Ministry of Citizenship and Multiculturalism
 - xi. Ministry of Agriculture, Food and Rural Affairs
 - xii. Infrastructure Ontario
 - xiii. Electrical Safety Authority
 - xiv. Independent Electricity System Operator
- k. The following federal government departments:
 - i. Transport Canada
 - ii. Indigenous Services Canada

- 3. To post a copy of the Notice, the application and the evidence, and any amendments thereto, on Hydro One's website.
- 4. To file with the OEB an affidavit in both electronic and paper forms proving completion of the matters in paragraphs 1 through 3 above, immediately thereafter with the relevant Notices and original post office registration receipts (where applicable), or courier confirmation lists attached as appendices.
- 5. To provide a copy of the Notice, application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any documents or materials when serving the Notice other than documents or materials expressly required by this letter of direction to be served.
