## Re: Niagara Reinforcement Limited Partnership (NRLP) 2025-2029 Transmission Revenue Requirement Application Ontario Energy Board File Number: EB-2024-0117

The Ontario Energy Board (OEB) has now issued its Notice of Hearing for the Niagara Reinforcement Limited Partnership (NRLP) 2025-2029 Transmission Revenue Requirement Application (Notice). - 2. To post the enclosed English and French versions of the Notices, the application and evidence, and any amendments thereto, on NRLP's website.
- 3. To post the following message if NRLP has an X (formerly Twitter), LinkedIn, Facebook, and/or Instagram account:

- a) "We have applied to the Ontario Energy Board to change our electricity transmission rates. Learn more. Have your say."
- b) « Nous avons déposé une requête auprès de @OntEnergyBoard afin modifier ses tarifs de transport d'électricité. Soyez mieux renseigné. Donnez votre opinion. »

The posts are required to include the Bigbox Ad and to provide a link to the Notices as posted on NRLP's website in accordance with paragraph 2.

- 4. To provide a copy of the Notices, the application and evidence, and any amendments thereto, to anyone requesting the material.
- 5. To file with the OEB an affidavit confirming that the steps set out in paragraphs 1 through 3 have been completed.

You are further directed not to include any documents or materials when serving or publishing the Notices other than documents or materials expressly required by this letter of direction.
