Re: EB-2022-0157 – Enbridge Gas Inc. – Panhandle Regional Expansion Project

Please see the enclosed revised cost claim of Environmental Defence in the above matter. This has been revised to include the costs for the entire proceeding, including the amounts attributable to the interim costs granted after the proceeding was put into abeyance in accordance with *Procedural Order #5*. The cost claim we filed on May 28 did not include the entire amount of costs as I had not looked back at the previous procedural order from 2023. I apologise for the oversight.

As noted in our original covering letter of May 28, 2024, this cost claim includes the costs for Dr. Heather McDiarmid to update her evidence, prepare for the hearing, and attend the hearing, which amounted to \$5,015 (plus tax). This work was not part of the initial cost estimate for Dr. McDiarmid's evidence. However, the total cost of Dr. McDiarmid's evidence before and after the abeyance still fell within the he OEB-approved cost estimate of \$7,000 to \$14,000 for the report, plus 5 to 15% for additional steps.
