Issues:

Pollution Probe has a material interest specific to the issues included in the application, including the balances and proposed disposition of the deferral and variance accounts. Of particular note is the IRP Operating Costs Deferral Account included in the application which includes a request for costs related to incremental IRP activities, including costs for Capital project avoidance (IRPA) and implementation of IRP requirements in accordance with EB-2020-0091. Although IRP related issues have been considered in EB-2020-0091, EB-2022-0200 and other proceedings, this proceeding is specifically focused on OEB review and approvals for the amounts included in the account proposed to be cleared.
