LETTER OF DIRECTION

Dear Eryn Mackinnon:

Re: Chatham x Lakeshore Limited Partnership 2025-2029 Transmission Revenue Requirement Application Ontario Energy Board File Number: EB-2024-0216

The Ontario Energy Board (OEB) has now issued its Notice of Hearing for the Chatham x Lakeshore Limited Partnership (CLLP) 2025-2029 Transmission Revenue Requirement Application (Notice). The Notice will be published by the OEB in hard copy newspapers, in accordance with directions to the OEB's media agent which were copied to you. Please note that you must comply with the directions in paragraphs 1 to 4 below prior to **August 15, 2024**, which is the publication date of the newspaper in which the Notice will appear last. If you are unable to comply with the directions within this timeframe, you must inform the Registrar immediately at <u>registrar@oeb.ca</u>.

You are directed:

- 1. Arrange for the service of each of the enclosed English and French versions of the Notice, in the exact form accompanying this letter and the application and the evidence, to all licenced transmitters in Ontario.
- 2. To arrange for the service of the English Notice, the application and the evidence, directly on all intervenors of record in CLLP's leave to construct proceeding, EB-2022-0140.
- 3. To post the enclosed English and French versions of the Notices, the application and evidence, and any amendments thereto, on CLLP's website (or Hydro One Network Inc.'s website, if CLLP does not have a website).

- 4. To post the following message if CLLP has an X (formerly Twitter), LinkedIn, Facebook, and/or Instagram account:
 - a) "We have applied to the Ontario Energy Board for approval of our electricity transmission rates. Learn more. Have your say."
 - b) « Nous avons demandé à la Commission de l'énergie de l'Ontario d'approuver nos tarifs de transport d'électricité. Soyez mieux renseigné. Donnez votre opinion. »

The posts are required to include the Bigbox ad and to provide a link to the Notices as posted on CLLP's website in accordance with paragraph 2.

- 5. To provide a copy of the Notices, the application and evidence, and any amendments thereto, to anyone requesting the material.
- 6. To file with the OEB an affidavit confirming that the steps set out in paragraphs 1 through 4 have been completed.

You are further directed not to include any documents or materials when serving or publishing the Notices other than documents or materials expressly required by this letter of direction.
