Please find attached a schedule for the Presentation Day on September 5, 2024. The Ontario Energy Board (OEB) expects that the Presentation Day will conclude in one day. Also, following the issuance of Procedural Order No. 3 on August 7, 2024, OEB staff received some questions about the Presentation Day. In response, the OEB offers the following clarifications.

First, the OEB reiterates that on the Presentation Day it is only expecting presentations from the four experts who have prepared expert reports. The purpose of Presentation Day is to present the evidence to the Commissioners. Experts are expected to provide a summary of their reports, including key recommendations, focusing on issues where there is a difference of opinion among the experts. While Presentation Day is not for all parties to outline their positions on the issues, there will be an opportunity to make an opening statement at the outset of the oral hearing which is scheduled to begin on September 25, 2024. Furthermore, all parties will have the opportunity for written submissions following the hearing.

Second, the OEB can confirm that despite Procedural Order No. 1, issued on March 28, 2024, no party is required "to file a description of the specific areas on which they will be focusing and an estimate of time required for each area of focus" in advance of the Presentation Day. As set out in Procedural Order No. 3, anyone who wishes to attend the Presentation Day must register with the Registrar by August 29, 2024, and all experts' presentation materials must be submitted to the Registrar by September 3, 2024.
