Hi Paul,

Please see our responses to your comments below in blue:

1. With respect to the RTSRs, and UTRs, we do not yet have approved values for 2017. Can you please advise when EnWin can expect to receive the OEB approved adjustment for UTRs for 2017? Will this be reflected on EnWin's final approved Decision and Rate Order?

The 2017 UTRs are not available now. Currently, the UTRs will remain the same as the 2016 UTR's and any differences will be accumulated in the RSVA Transmission Network and RSVA Transmission Connection for future disposition.

2. For Schedule A, Tariff of Rates and Charges, EnWin has heard through press releases from the Ministry's office pertaining to Ontario's Fair Hydro Plan that the regulatory charges (i) Rural or Remote Electricity Rate Protection Charge (RRRP); and (ii) Ontario Electricity Support Program Charge (OESP) are intended to be removed from customers' bills. Please advise when EnWin can expect to receive the OEB approved changes for the RRRP Charge and OESP Charge on the Tariff of Rates and Charges. Will this be reflected on EnWin's final approved Decision and Rate Order?

It has not been determined how and when this will happen.

3. On page 2 and page 3 of Schedule A, Tariff of Rates and Charges, EnWin has heard through press releases from the Ministry's office pertaining to Ontario's Fair Hydro Plan that the Ontario Electricity Support Program Recipient (OESP) credits may be increasing. Please advise when EnWin can expect to receive the OEB approved changes for the OESP Credits on the Tariff of Rates and Charges. Will this be reflected on EnWin's final approved Decision and Rate Order?

It has not been determined how and when this will happen.

4. On page 11 of Schedule A, Tariff of Rates and Charges, in the Customer Class 'Large Use - Ford Annex Service Classification', under the Application heading, the paragraph describing the rate rider for the disposition of Global Adjustment can be removed. This is a single incumbent class who is a Wholesale Market Participant. There is no possibility of new customers in this class.

The paragraph describing the Global Adjustment rate rider will be removed from the "Large Use – Ford Annex Service Classification" rate class on the Tariff.
