



Hydro One Networks Inc.

Application for 2025 Transmission Revenue Requirement

PROCEDURAL ORDER NO. 1

August 27, 2024

Hydro One Networks Inc. (Hydro One) filed an application with the Ontario Energy Board (OEB) on July 19, 2024, under section 78 of the *Ontario Energy Board Act, 1998*, seeking approval of its annual revenue requirement for electricity transmission, effective January 1, 2025, and inclusion of its approved revenue requirement in the Uniform Transmission Rates. Hydro One is also seeking to dispose of the balance in the Excess Export Services Revenue Account as of December 31, 2023, as well as approval of the Export Transmission Service rate for 2025.

A Notice of Hearing was issued on August 9, 2024. The OEB did not receive any intervention requests.

At this time, the OEB is making provision for the filing of written interrogatories, responses to interrogatories and written submissions. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

1. OEB staff shall request any relevant information and documentation from Hydro One that is in addition to the evidence already filed, by written interrogatories filed with the OEB and served on Hydro One by **September 6, 2024**.
2. Hydro One shall file with the OEB complete written responses to all interrogatories and serve them on OEB staff by **September 20, 2024**.
3. Any written submissions by OEB staff shall be filed with the OEB by **October 2, 2024**.
4. Hydro One may file a written reply submission with the OEB by **October 15, 2024**.

Parties are responsible for ensuring that any documents they file with the OEB, such as evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's [Rules of Practice and Procedure](#).
