Re: Generic Proceeding – Cost of Capital and Other Matters
Board File No.: EB-2024-0063

We are counsel to Caldwell First Nation (“**CFN**”) and Mississaugas of the Credit First Nation (“**MCFN**”), as joint-intervenors, in the above-noted proceeding (the “**Proceeding**”). Pursuant to Procedural Order No. 3, please find attached the interim cost claims of CFN in the Proceeding.

Submissions. CFN respectfully request an award of 100% of its eligible costs, given its strategic and principled participation in the Proceeding to date, reflecting the unique interests of CFN and its members. CFN submits that this request is supported by the following considerations:

- (i) CFN has participated effectively in the Proceeding, taking a surgical, principled, and coordinated approach to matters related to the rights and concerns of CFN and its member and assisted in contributing to the Board’s better understanding of such concerns and matters;
- (ii) CFN has ensured that its participation in the Proceeding has been focused on material issues and consistent with the scope of its joint intervention, as set out in its joint Notice of Intervention;
- (iii) CFN has coordinated significantly with MCFN and other Indigenous intervenors to participate cost-effectively in order to limit overlap and efficiently advance issues of mutual interest; and
- (iv) CFN has participated responsibly to avoid overlap, maximize efficiency, and ensure that its participation was not unduly repetitive and was focused on relevant and material issues.

We trust that this approach has maximized the efficient use of resources and the right of otherwise unrepresented and important Indigenous energy customers and stakeholders to be heard in a manner that is consistent with the Board’s mandate and statutory objectives.

CFN respectfully requests a full award of eligible interim costs.
