NOTICE OF A RATE HEARING

EPCOR Natural Gas Limited Partnership has applied to increase its natural gas distribution rates in its South Bruce service territory

The requested rate increases are set using an OEB-approved formula, which is tied to inflation and other factors intended to promote efficiency. If the application is approved as filed, typical general service customers of EPCOR Natural Gas Limited Partnership (ENGLP) in its South Bruce territory would see the following increases effective January 1, 2025:

Rate Class	Annual Bill Increase (including applicable rate riders)
General Service Existing Residential	\$141 per year
General Service New Residential	\$138 per year
General Service Small Commercial	\$223 per year

Other customers, including businesses, will also be affected. It is important to review the application carefully to determine whether you may be affected by the proposed changes.

ENGLP has also applied to dispose of the balances in certain deferral and variance accounts, including the Customer Volume Variance Account.
