

Hydro One Remote Communities Inc. gii-onji-gagwedwem ji-aanjitoong ezhi-zhooniyaakeng waa-izhi-ayaamingoban mayaajitaang Iskigamizige-giizis 16, 2024

Hydro One Remote Communities Inc. (Waasomowin Bezhiig Waasa Oodenawan Inc.) (Waasa) gii-onji-gagwedwem imaa Ontario Energy Board ji-aanjitoong ezhi-zhooniyaakeng waa-izhi-ayaamingoban mayaajitaang Iskigamizige-giizis 16, 2024 ji-gashkitoong apiichi-giishpinachigeng enagindeg Shoulderblade Hydel waasomowin wenji-ozhichigaadeg waakaa'igan (Hydel).

Aazhi, Hydel gaa-izhi-dibenjigaadeg miinawaa gaa-izhi-dazhiikaming onji imaa Deer Lake First Nation miinawaa Waasa, miinawaa enagindeg gii-atewan imaa Waasa' gaa-odaapinigaadeg enagindeg. Baamaa Deer Lake First Nation's gii-aanikesijigeng imaa Wataynikaneyap Power waasomowineyaabiing, gaa-onji-diba'igaadeg Waasa biinish Deer Lake First Nation gii-ishkwaasewan.

Hydel noongom izhi-anokiimagad ayaawang gaa-boozibii'igaadesinoog waasomowinikewin. Waasa noongom izhi-gagwedwem ji-izhi-odaapinigaadeg:

- Record imaa Waasa gemaa gaye Rural Rate Protection Variance Account Hydel's endaso-gikinoonowin enagindeg, gaye minik gaa-izhi-diba'igaadeg onji Deer Lake First
- Waa-izhi-webinigaadeg iw Remote gemaa gaye Rural Rate Protection Variance Account wayiiba nitam wii-aanjichigaadeg boozibii'igaadeg

Ezhi-odaapinigaadeg iw Ezhi-boozibii'igaadeg ji-izhi-odaapinigaadeg 0.18% onji endaso-gikinoonowin provincial Remote gemaa gaye Rural Rate Protection enagindeg. Apiitendaagwad ji-agindaming iw ezhi-boozibii'igaadeg weweni ji-gikendaming ezhiwebiziyen ezhi-doodaagoyan iw endazhindaming ayaanjichigaadeg.
