The application requests leave, of the Board to acquire the remaining shares of ELEK Energy inc. (ELK), a licensed electricity distributor. The Board has assigned the application file number EB-2008-0310.

Essex currently holds 38% of the Issued and outstanding common shares in ELK. Essex has entered into a Share Purchase Agreement with the other into shareholders of ELK, namely the Town of Kingsville, (Kingsville), a 38% shareholder, and the Town of Lakeshore (Lakeshore) a 24% shareholder, where the Essex intends to purchase all of the common shares of ELK held by Kingsville and Lakeshore. The share purchase transaction will make Essex the sole stransholder of ELK Le with 100% shareholdings.
