DECISION AND ORDER ON INTERIM COST AWARDS

EB-2024-0063

A generic proceeding commenced by the Ontario Energy Board on its own motion to consider the cost of capital parameters and deemed capital structure to be used to set rates

OVERVIEW

On March 6, 2024, pursuant to sections 36, 78 and 78.1 of the Ontario Energy Board Act. 1998 (OEB Act), the OEB issued a Notice of Hearing on its own motion to initiate a generic proceeding to consider the methodology for determining the values of the cost of capital parameters and deemed capital structure to be used to set rates for electricity transmitters, electricity distributors, natural gas utilities, and rate-regulated electricity generators. The OEB also noted that it will determine whether its current approach to setting the cost of capital parameters and deemed capital structures continue to remain appropriate and if not, what approach should be used.

In addition, this proceeding will consider the methodology for determining the OEB's prescribed interest rates and what type of interest rate, if any, should apply to the generic Cloud Computing Deferral Account.¹

As noted in the OEB's Procedural Order (PO) No. 1 dated March 28, 2024, the OEB made a provision of cost awards (and any applicable costs incurred by the OEB) under Section 30 of the OEB Act. The OEB noted that these amounts will be recovered from all rate-regulated electricity distributors, rate-regulated electricity transmitters, rate-regulated natural gas utilities, and rate-regulated electricity generators (collectively, rate-regulated companies). The four groups will each be allocated a 25% share and in turn be sub-allocated amongst the utilities comprising that group, by the OEB's Cost Assessment Model. No objections to this approach were filed.

The OEB determined that the following parties are eligible for cost awards (collectively the Eligible Participants):

- Association of Major Power Consumers in Ontario (AMPCO)
- Association of Power Producers of Ontario (APPrO)
- Building Owners and Managers Association (BOMA)
- Caldwell First Nation and Mississaugas of the Credit First Nation (jointly represented) as: CFN & MCFN)²
- Canadian Manufacturers & Exporters (CME)
- Coalition of Concerned Manufacturers and Businesses of Canada (CCMBC)
- Consumers Council of Canada (CCC)
- Energy Probe Research Foundation (Energy Probe)
- Industrial Gas Users Association (IGUA)
- Pollution Probe
- School Energy Coalition (SEC)

- Three Fires Group Inc. and Minogi Corp. (jointly represented as: TFG & Minogi)³
- Vulnerable Energy Consumers Coalition (VECC)

Directions on filing for interim cost awards were provided to parties in the OEB's August 7, 2024, Decision on Procedural Matters and Procedural Order No. 3 (PO 3). The OEB provided that the Eligible Participants could file cost claims up to and including September 6, 2024. PO 3 also accepted the Small Business Utility Alliance's request to withdraw from the proceeding.

Interim cost claims were received from AMPCO, APPrO, BOMA, CFN, CME, CCMBC, CCC, Energy Probe, IGUA, MCFN, Minogi, SEC, and TFG.

Findings

The OEB has reviewed the interim cost claims filed to ensure they are compliant with the OEB's *Practice Direction on Cost Awards* (Practice Direction).

The OEB finds that the interim cost claims from AMPCO, APPrO, BOMA, CFN, CME, CCMBC, CCC, Energy Probe, IGUA, MCFN, Minogi, SEC, and TFG are sufficiently documented for the purposes of an interim cost award and shall be reimbursed by the rate-regulated companies.

The OEB approves interim cost awards for the Eligible Participants as follows:

- AMPCO \$26,101.36
- APPrO \$1,065.59
- BOMA \$6,059.63
- CFN \$2,176.00
- CME \$9,098.76
- CCMBC \$3,915.45
- CCC \$19,153.50
- Energy Probe \$4,217.41
- IGUA \$84,521.47
- MCFN \$2,159.00
- Minogi \$4,219.50
- SEC \$19,233.73
- TFG \$3,540.29

The OEB is also ordering recovery from rate-regulated companies of \$252,782.03 for the OEB's costs of and incidental to this proceeding.

As noted in PO 3, the OEB will conduct a complete review of all cost claims for the entire proceeding at its conclusion. The Eligible Participants will be required to submit an incremental cost claim at the conclusion of the proceeding. A provision will be made for the rate-regulated companies to file any objections at that time, and any Eligible Participants whose claims were subject to objections will have an opportunity to reply. The OEB will then determine the Eligible Participants' entitlement to a cost award, including any amount received as an interim award, and interim awards of costs may be subject to adjustment at that time.

Process for Paying Cost Awards

The amounts payable by each rate-regulated company in relation to costs awarded to each Eligible Participant are listed in Schedule A to this Decision and Order. However, the amounts will not be paid directly by the rate-regulated companies to the Eligible Participants.

The OEB will use the process set out in section 12 of the Practice Direction to implement the payment of the approved cost awards whereby the OEB will act as a clearing house for all payments of cost awards. Consistent with this process, each rate-regulated company is issued one invoice that covers all cost awards payable for the relevant period. As a result, the invoice would cover cost awards payable in relation to a number of proceedings and consultations, including this proceeding.

The invoice will be sent out at the same time as the invoices for cost assessments under section 26 of the OEB Act, and payment will be due at the same time that cost assessments are due. The OEB makes payment to each Eligible Participant once 80% of the costs have been recovered by the OEB.

THE ONTARIO ENERGY BOARD ORDERS THAT:

- 1. Each rate-regulated company in Schedule A to this Decision and Order shall make a payment to the OEB in accordance with the amounts set out in Schedule A, upon receiving an invoice from the OEB.
- 2. Pursuant to section 30 of the OEB Act, each rate-regulated company shall pay the OEB's costs of, and incidental to, this proceeding immediately upon receipt of the OEB's invoice.
