Enbridge Gas has reviewed the October 16 submissions of parties on their intended topics for questioning of the Company's witnesses at the October 30-31, 2024 Technical Conference for the above noted proceeding, and is submitting the names listed in the table below as witnesses for the Enbridge Gas panel. Enbridge Gas is planning to have one panel comprised of all witnesses.

Having reviewed the specific topic areas OEB Staff and intervenors intend to cover, we have expanded the witness panel to ensure the various areas are covered by appropriate Enbridge Gas witnesses.

Enbridge Gas has considered the request of Environmental Defence (ED) to include witnesses from Posterity and Integral as part of the Enbridge Gas witness panel. Upon review of the OEB's direction in Procedural Order (PO) No. 2, specifically that "the OEB will convene a transcribed technical conference for parties to ask clarification questions related to interrogatory responses filed by Enbridge Gas" (emphasis added), and upon further review of the small number of interrogatory responses which relate to the work of Posterity and Integral, our view is that the interrogatories (including the ones specifically noted by ED in its letter) do not warrant the addition of witnesses from Posterity and Integral to the Enbridge Gas panel in the circumstances.

Out of the total 186 interrogatories responded to in this proceeding, only five of the interrogatory questions made reference to Posterity, and only two of those required responses directly from Posterity. Only six interrogatory questions made reference to Integral, and none of those required a response directly from Integral. Enbridge Gas believes that clarification questions on these responses are appropriately directed to

Enbridge Gas witnesses, and if a situation arises where clarification is required from Posterity or Integral, these questions can be handled by way of undertakings. Further, this approach will make the most efficient use of the limited time (intervenors have proposed over 10 hours of questioning, in addition to the time required for OEB Staff questions) provided by the Technical Conference schedule – to enable the Technical Conference to be completed within the two days - and is consistent with the OEB's direction in PO No. 2.
