Issues:

Members of the Coalition of Concerned Manufacturers and Businesses of Canada are commercial and industrial customers of Lakefront Utilities. The rates they pay will be impacted by the application by Lakefront Utilities for the recovery of the Victoria Street Transformer Station costs through the ICM funding mechanism instead of charging a contribution in aid of construction from the developer that is served by the station.
