DECISION AND ORDER

Union Gas Limited ("Union") filed an application dated September 10, 2008 with the Ontario Energy Board (the "Board") under section 8 of the *Municipal Franchises Act*, R.S.O. 1990, c. M.55, as amended (the "Act"), for an order of the Board cancelling the existing Certificates of Public Convenience and Necessity for the former Township of Adelaide and the former Township of Metcalfe and replacing them with a Certificate with a Certificate of Public Convenience and Necessity for the amalgamated Township of Adelaide Metcalfe. The Board has assigned file number EB-2008-0302 to this application.

The Board's Notice of Application and Written Hearing was published on October 1, 2008. There were no intervenors. Union has Certificates of Public Convenience and Necessity granting Union the right to construct works to supply natural gas to the former Township of Adelaide (F.B.C. 128) and the former Township of Metcalfe (E.B.C. 30). On January 1, 2001, by Minister's Order, the former Townships of Adelaide and Metcalfe were amalgamated to form the Township of Adelaide Metcalfe.

The Board finds that it is in the public interest to grant the application and that public convenience and necessity requires that approval be given.

IT IS THEREFORE ORDERED THAT:

- The Certificate of Public Convenience and Necessity attached as Appendix A to this Decision and Order replaces Certificates F.B.C. 128 and E.B.C. 30 relating respectively to the former Township of Adelaide and the former Township of Metcalfe.
- 2. The Certificate of Public Convenience and Necessity, attached as Appendix A to this Decision and Order, is granted to Union Gas Limited to construct works to supply gas in the Township of Adelaide Metcalfe.
