Re: Enbridge Gas Inc. Application for Certificate of Public Convenience and Necessity Town of Ajax Ontario Energy Board File No. EB-2024-0234

Further to the questions submitted by Ontario Energy Board Staff related to certificates of public convenience and necessity, Enbridge Gas provides the following responses.

Staff Question-1

Reference: EB-2024-0234, Application, page 1, para 3, 4 and 5 EB-2024-0234, Application, page 2, para 8

Preamble:

Enbridge Gas notes that the boundaries of the Town of Ajax were expanded to include several areas of the former Township of Pickering, including the former Village of Pickering, the former community of Pickering Beach and the former Village of Audley.

Enbridge Gas states that it holds certificate rights for all of the lands that now make up the Town of Ajax through the following certificates:

- F.B.C. 9, dated May 15, 1956 for the former Village of Pickering
- F.B.C. 10, dated May 15, 1956 for the former Township of Pickering
- F.B.C. 75 dated August 20, 1956 for the former Town of Ajax

Enbridge Gas has requested orders cancelling and superseding the F.B.C. 9 certificate related to the former Village of Pickering and the F.B.C. 75 Certificate related to the former Town of Ajax and replacing them with a Certificate to supply natural gas in the current Town of Ajax.

Questions:

a) Please discuss why Enbridge Gas has not requested that those parts of F.B.C. 10 related to the former Township of Pickering that became part of the Town of Ajax be cancelled and replaced by a new certificate for the Town of Ajax.

b) Please discuss which municipalities are covered by F.B.C. 10. If there are no municipalities covered by F.B.C 10, please discuss whether F.B.C. 10 could be cancelled.

Response:

a) The F.B.C. 10 CPCN (see attachment 1) is related to the former Township of Pickering only. On January 1, 1974, the southeastern portion of the former Township of Pickering, including the former Village of Pickering (covered by F.B.C. 9) became part of the Town of Ajax. The rest of the former Township of Pickering became the Town of Pickering, which in 2000 became the City of Pickering.

Subsequent to the application dated July 23, 2024 associated with the request for a new CPCN for the Town of Ajax, the parts of F.B.C. 10 relating to the former Township of Pickering that formed the City of Pickering were cancelled and superseded by the CPCN issued on September 19, 2024 for the City of Pickering in the EB-2024-0205 proceeding.

This current application should include a request to cancel and supersede the remaining parts of F.B.C. 10. Paragraph 8 of the original application should be updated as follows:

8. Enbridge Gas now applies to the Ontario Energy Board for an Order pursuant to s.8 of the Municipal Franchises Act cancelling and superseding the F.B.C. 9 Certificate of Public Convenience and Necessity held by Enbridge Gas Inc. related to the former Village of Pickering, those parts of the F.B.C. 10 Certificate of Public Convenience and Necessity held by Enbridge Gas Inc. related to those parts of the former Township of Pickering that became part of the Town of Ajax, and the F.B.C. 75 Certificate of Public Convenience and Necessity held by Enbridge Gas Inc. related to the former Town of Ajax and replacing them with a Certificate of Public Convenience and Necessity to construct works to supply natural gas in the current Town of Ajax.

b) See the response to part (a). The F.B.C. 10 CPCN still applies to those parts of the former Township of Pickering that became part of the Town of Ajax and can be superseded by a new CPCN for the Town of Ajax.
