Re: SYNERGY NORTH CORPORATION - 2025 Electricity Distribution Rate Application EB-2024-0055

Synergy North Corporation (SYNERGY NORTH) was established as a licensed electricity distributor on January 1st, 2019 through a Board approved MAAD Application (EB-2018-0124). SYNERGY NORTH serves over 55,000 customers in Northwestern Ontario in two separate rate zones.

The rate zones are divided into:

- 1) Thunder Bay Rate Zone serving Thunder Bay and Fort William First Nations;
- 2) Kenora Rate Zone serving Keewatin and Kenora.

SYNERGY NORTH is applying for authorization to adjust its current electricity distribution rates in accordance with the *Ontario Energy Board Filing Requirements for Electricity Distribution Rate Applications – 2024 edition for 2025 Rate Applications - Chapter 3 – Incentive Rate-Setting Applications* dated June 18, 2024.
