

# DECISION AND ORDER EB-2024-0177

## AYPA POWER CANADA LP

**Application for an Electricity Storage Licence Amendment**

#### **Decision and Order**

Aypa Power Canada LP (Aypa Power) filed a complete application on October 1, 2024, with the Ontario Energy Board (OEB) pursuant to section 74 of the *Ontario Energy Board Act*, 1998 (OEB Act), to amend electricity generation licence ES-2022-0092.

This Decision and Order is being issued by the Delegated Authority pursuant to Section 6 of the OEB Act. The Delegated Authority has considered the application without holding a hearing pursuant to section 6(4) of the OEB Act.

Aypa Power is, among other things, an owner and operator of a fleet of embedded energy storage facilities that provide behind the meter services to certain distribution load customers. Aypa Power explained that it is requesting the amendment of its storage licence to include a number of storage facilities that it operates because it intends to participate in the IESO's upcoming capacity auction.

Specifically, Aypa Power has requested an amendment to Schedule 1<sup>1</sup> of its electricity storage licence to:

- i) add a storage facility operated by Aypa Power located at 2335 Speers Rd.
  Oakville, Ontario. The facility is owned by Monarch LP.
- add a storage facility operated by Aypa Power located at 7200 Martin Grove Rd.,
  Woodbridge, Ontario. The facility is owned by Aypa Power GL LP.
- iii) add a storage facility operated by Aypa Power located at 450 Thomas St., Ingersoll, Ontario. The facility is owned by ORS LP.
- iv) add a storage facility owned and operated by Aypa Power located at 5300 Tomken Rd., Mississauga, Ontario
- v) add a storage facility owned and operated by Aypa Power located at 400 Humberline Dr., Etobicoke, Ontario
- vi) add a storage facility owned and operated by Aypa Power located at 1770 Fiddlers Green Rd., Ancaster, Ontario

- x) add a storage facility owned and operated by Aypa Power located at 1506 Wentworth St., Whitby, Ontario
- xi) add a storage facility owned and operated by Aypa Power located at 313 Menno St. RR 2, Breslau, Ontario
