This letter is in response to the Ontario Energy Board's correspondence dated November 8, 2024, regarding the application for an electricity retailer licence for Energy Canada Home Comfort Ltd. We appreciate your review of our application and have addressed the requested points below:

1. Trade Name  
Energy Canada Home Comfort Ltd. will proceed under its full legal name for now as the trade name "Energy Canada" has not yet been registered. If and when the trade name is officially registered, we will promptly submit the required documentation to the OEB.
2. Intended Markets and Services  
Energy Canada Home Comfort Ltd. intends to sell electricity directly to both low and large-volume consumers.
3. Corporate Organization Chart  
After discussions with our assigned analyst, Mahnoor Mir, it was determined that the organizational chart provided with our application is sufficient. Energy Canada Home Comfort Ltd. does not have any affiliated sister, or parent companies, it operates as an independent entity.
4. Financial Statements  
Unfortunately, audited financial statements are not available at this time. The net loss and lower current assets reported in 2023 compared to 2022 are primarily due to a strategic shift in our business operations. In 2022, Energy Canada Home Comfort Ltd. billed for several other organizations. However, in 2023,

certain aspects of the business were ceased to focus on ventures aimed at generating independent revenue streams.


5. Relationship with Alexian Computer Services Inc.
