

NOTICE OF A HEARING

Hydro One Networks Inc. ogagwejimaawaa' Ontario Energy Board gaa-anokaadamowaad izhi-gagwedwewag ji-inaabiiginigewaad Zhaniya imaa odenaang Odikwaning Anteriiyo

Hydro One Networks Inc. (Hydro One) ogagwejimaawaa' Ontario Energy Board gaa-anokaadamowaad (OEB) izhi-gagwedwewag ji-inaabiiginigewaad Zhaniya imaa odenaang Odikwaning Anteriiyo, ji-ozhitoowaapan ji-anokiimagak oshki-230 kilovolt ge-niizhwaabiigamogin omaa Lake Transformer Station (TS) biinish igo Mackenzie TS (enokaadamowaad).

Anokiwin owe niizhwewanagad. Owe bezhig 1 anokiwin 230 kilovolt ge-niizhwaabiigamogin 190 km akoosin anokiwin mii omaa ge-ani-ayaa'aanikoosinging Lakehead TS omaa Mackenzie TS. Iwedi bezhig eko-niizhing 2 anokiwin oshki-230 kV bezhigooyaabiigiman 170km akwaabiigagoode biinish Mackenzie TS gaye Dryden TS. Owe gaa-bizhigwang 1 anokiwin wii-maajitaawaag Manidoowigiizisoons 2025, Iwedi eko-niizhing wii-maajichigaade Manidoowigiizisoons 2027.

Iwedi bezhig gii-inaawag ji-maajitaawaad Iskigamizigegiizis 16, 2024 Ontario Energy Board ge-andanwendaagoziwag Hydro One ji-anokaadamowaad.

Hydro One akawe da-gagwedwewag 136 gaa-dibendamowaad akiinsan giishpin ji-anokaadamowaapan owe bezhig 1 anokiwin. Ogowe eko-niizhing 2 gaawin memwech da-gagwedwesiwag ji-anokaadamowaapan akiinsan.

Hydro One ogikendaanaawaa aanind gaa-dibendaman gidakiim Hydro One gagwedwewag ji-aabajitoowaad owe aki eko-bezhigwan 1 anokiwinan. Akii-mazina'igan ayaa ezhinaagwak omaa akiing waa-anokaadeg Hydro One miinigoowin mazina'igan da-mazinaakide Akii-mazina'igan.

Hydro One mii eta go minik owe ezhi-andawendamowaad. Gaawin noon onji-zhooniyaa. OEB miinawaa wii-anokaadamowaad akawe gakina awiya da-gagwejimaawag. OEB gaawin niinawind gegoo nindaa-ikidosiimin engindeg akiinsan. Giishpin odaapinang Hydro One awiya odakiim giishpin minwendanzig enagindeg aki, dayizhi-wiijigaade dibaakonigewigamigong *Expropriations Act*.
