Hydro One Networks Inc. ("Hydro One") writes further to the Letter of Direction dated December 2, 2024, in the above noted matter.

Hydro One herein submits an Affidavit of Service sworn by Eryn Mackinnon dated December 19, 2024, attesting to the matters completed as required in paragraphs 1 through 3 of the Letter of Direction. With respect to paragraph 2 of the Letter of Direction, and as detailed in Ms. Mackinnon's affidavit at paragraph 6, Hydro One has been unable to complete service on one registered interest holder, (the "Chargee"), related to a Charge registered on title in 1986 for \$13,460.

Hydro One has undertaken reasonable and diligent efforts to locate an address for service for the Chargee which included a Title search, Obituaries search, Property Tax Roll search, Law Firm search, and Property Owner search as further described in Ms. Mackinnon's affidavit, which searches did not return any results. Based on the foregoing, Hydro One requests that no further steps be required for service of the Chargee.

AFFIDAVIT OF ERYN MACKINNON

I, Eryn MacKinnon, of the City of Toronto, in the Province of Ontario, MAKE OATH AND SAY AS FOLLOWS:

- 1. I am employed as a Regulatory Advisor in the Regulatory Affairs Division of the Applicant, Hydro One Networks Inc. ("Hydro One").
- 2. Hydro One has complied with the Ontario Energy Board's Letter of Direction dated December 2, 2024, in respect of EB-2024-0319 (the "Letter") as set out below.
- 3. In accordance with paragraph 1 of the Letter, Hydro One has conducted a title search sufficient to determine the current registered property owners and encumbrancers with lands or interests directly affected by the proposed expropriation application. I have been advised and do truly believe that this search has been completed as required.
- 4. In accordance with paragraph 2 of the Letter, Hydro One served each of the property owners or entities identified as holding a direct or registered interest in lands that are the subject matter of this Application. For property owners or entities represented by counsel, and where electronic service was accepted, the Notice package included:
 - English and Ojibway versions of the Notice of Hearing in EB-2024-0319;
 - The Application for Authority to Expropriate Land Interests of Hydro One Networks Inc. in EB-2024-0319;

 A legal description of the property in which the property owner has a direct or registered interest, along with ortho-rectified aerial maps and a reference plan of the affected area.

For property owners located outside of the country, where possible, Hydro One utilized both electronic service and courier service to ensure timely and reliable delivery of the Notice package. A copy of the emails sent to the property owners and/or their legal representatives is attached as **Exhibit "A"**.

- 5. In accordance with paragraph 2 of the Letter, the following information was sent between December 3, 2024, and December 6, 2024, by courier to each of the property owners and/or entities, which I was advised hold a direct or registered interest in lands that are the subject matter of this Application. The Notice package included:
 - English and Ojibway versions of the Notice of Hearing in EB-2024-0319;
 - The Application for Authority to Expropriate Land Interests of Hydro One Networks Inc. in EB-2024-0319;
 - A legal description of the property in which the registered interest holder has a registered interest, including ortho-rectified aerial maps and a reference plan of the affected area.

A copy of the courier manifest is attached as **Exhibit "B"** to this affidavit.

6. Hydro One was unable to effect service on one (1) registered interest holder in the subject properties. With respect to the registered interest holder whom Hydro One has not been able to contact, I am advised and do believe that Hydro One has taken reasonable steps to locate an address for the listed party to effect service in the manner prescribed in the Board's Letter of Direction. Despite these efforts, service could not be completed.

I confirm the following searches were conducted: a) Address listed on the Charge: A google search of the address confirmed the location is a parking lot. b) Title Search: Hydro One's real estate department has done a search of properties in the Thunder Bay area with the name of the Chargee and no search results were returned. c) General Obituaries Search: Returned no results for the Chargee.

- Property Tax Roll Search: Hydro One's Real Estate department reviewed the property tax roll information and there is no apparent link between the Chargee and the subject property or its current interest holders to locate an address for service. e) Inquiries with Law Firm that prepared the Charge: The law firm has advised that the lawyer of record for the
 - Chargee has been deceased since 2016 and the law firm has no client information for the Chargee.
 - **Property Owner Search:** The registered property owner is deceased. Hydro One's real estate department was able to locate next of kin who has declined to be involved with the estate or matters related to the subject property.

Based on the foregoing, Hydro One has undertaken reasonable and diligent efforts to locate the Chargee in accordance with the Ontario Energy Board's Letter of Direction, but service could not be effected.

7. In accordance with paragraph 3 of the Letter, the English and Ojibway versions of the Notice, the Application, and the Evidence were posted on Hydro One's website on December 6, 2024. A copy of the website posting is attached as Exhibit "C".
