Re: Enbridge Gas Inc. Application for Certificate of Public Convenience and Necessity Town of Collingwood Ontario Energy Board File No. EB-2024-0292

Further to the questions submitted by Ontario Energy Board Staff related to areas covered by the existing certificate of public convenience and necessity, Enbridge Gas provides the following response.

Staff Question-1

Reference: Application, page 1, para 3, 4 and 5 Application, page 3, page 11

Preamble:

In 1994, a portion of the former Township of Nottawasaga was annexed to the Town of Collingwood.

Enbridge Gas has applied for an order of the OEB canceling and superseding its existing F.B.C. 96 certificate related to the Town of Collingwood and those parts of its existing F.B.C. 265 certificate related to the former Township of Nottawasaga annexed to the Town of Collingwood.

Questions:

- a) Please discuss which municipalities are covered by the F.B.C. 265 certificate for the former Township of Nottawasaga and whether the certificate can be cancelled entirely.
- b) Please clarify if any part of the E.B.C. 266 certificate for the Township of Clearview should be cancelled.

Response:

a) The F.B.C. 265 certificate was issued on June 5, 1958 to the Consumers' Gas Company for the supply of natural gas to the inhabitants of the Township of Nottawasaga only. There are no other municipalities addressed by this certificate.

As noted in the application, on January 1, 1994, a portion of the former Township of Nottawasaga was annexed to the Town of Collingwood and the remaining parts of the former Township of Nottawasaga became part of the Township of Clearview.

The E.B.C. 266 certificate was issued on July 4, 1997 to the Consumers' Gas Company for the supply of natural gas to the inhabitants of the Township of Clearview. This certificate covers all areas of the former Township of Nottawasaga that had been annexed to the Township of Clearview and previously covered by the F.B.C. 265 certificate.

As a result, once a new certificate is issued for the Town of Collingwood, the F.B.C. 265 certificate can be cancelled.

b) The E.B.C. 266 certificate is still required for operating within the Township of Clearview so it should remain in effect.
