Northern Ontario Wires Inc.

Application for electricity distribution rates beginning May 1, 2025

PROCEDURAL ORDER NO. 3 January 8, 2025

Northern Ontario Wires Inc. (Northern Ontario Wires) filed a cost of service application with the Ontario Energy Board (OEB) on August 30, 2024, under section 78 of the *Ontario Energy Board Act*, 1998, seeking approval for changes to the rates that Northern Ontario Wires charges for electricity distribution, beginning May 1, 2025.

Procedural Order No. 1, issued on October 17, 2024, made provision for certain matters related to the proceeding, including the dates for the settlement conference, the filing of any settlement proposal, and OEB staff's submission on the settlement proposal.

The settlement conference took place on December 12-13, 2024.

On December 18, 2024, the OEB issued Procedural Order No. 2, approving an additional settlement conference date to take place on January 6, 2025 and revising the procedural steps for the remaining dates in the settlement process.

On January 7, 2025, the OEB was advised that parties had reached a tentative full settlement on all issues within the OEB-approved issues list. The parties also agreed to revised dates for the filing of a settlement proposal and OEB staff's submission on that proposal.

It is necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

- Any settlement proposal shall be filed with the OEB on or before **February 7**,
 2025.
- 2. Any submission from OEB staff on a settlement proposal shall be filed with the OEB and served on all parties by **February 14, 2025**.

Parties are responsible for ensuring that any documents they file with the OEB, such as applicant and intervenor evidence, interrogatories and responses to interrogatories or any other type of document, **do not include personal information** (as that phrase is defined in the *Freedom of Information and Protection of Privacy Act*), unless filed in accordance with rule 9A of the OEB's <u>Rules of Practice and Procedure</u>.
