Pursuant to Rule 20.01 of the OEB's *Rules of Practice and Procedure*, please accept this letter as Enbridge Gas's formal request to withdraw its Leave to Construct (LTC) application for the Overlea Project.

As a result of the OEB's Decision in EB-2024-0250<sup>1</sup>, Enbridge Gas withdraws its LTC application as per the expectations outlined in the OEB's letter dated August 1, 2024 in the EB-2024-0141 proceeding:

The OEB has placed Enbridge Gas's leave to construct application in abeyance as of July 19, 2024. The OEB expects that Enbridge Gas will withdraw its leave to construct application if the new exemption application to be filed by Enbridge Gas is approved by the OEB.<sup>2</sup>

Enbridge Gas respectfully requests that the OEB accept withdrawal of the application without conditions.
