**Peterborough Utilities Inc  
Electricity Generator License Application  
10 MW Hydro Electric Generation Project**

London Street Power Corporation (LSPC) is hereby requesting a transfer of its Electricity Generator License to Peterborough Utilities Inc. (PUI) in accordance with a restructuring of assets within the two companies.

On April 1<sup>st</sup>, 2014 PUI executed a First Amending Agreement to HCI Contract No. HCI-0001 with the Ontario Power Authority to expand the generation capacity of the London Street Generating Station from 4 MW to a total nameplate capacity of 10 MW through the construction of new 6 MW facility. This new facility was commissioned in 2016 and in conjunction with this undertaking, PUI originally structure the ownership of these generating assets under its subsidiary, LSPC. At this time, PUI is seeking to consolidate its facilities under PUI's direct ownership and control

Accordingly, concurrent with issuance of a new electricity generation license to PUI, the following will occur:

1. LSPC will undertake, with the approval of the Independent Electricity System Operator, assignment and novation of HCI Contract #HCI-0001 (as amended) from LSPC to PUI. This assignment was recently completed by the IESO on July 6<sup>th</sup>, 2018;
2. LSPC will transfer ownership of the Existing Facility and all of its interests in the LSGS Facility to Peterborough Utilities Inc.;
3. LSPC, through this application is also requesting an amendment of its existing Electricity Generation License ~~EG-2003-0110~~ to remove ownership of the Existing London Street Generating Station Facility.


