Hi Hoda,

I will have JR and Richard provide a completed Section 12 form as you requested. I will try to get that to you the week of the 19th since they are both away right now.

"Pay per use model" Clarification:

Many multi-residential buildings only have 1 electricity meter servicing the whole building. To move them from a bulk metered system to a submetered system we install individual Measurement Canada sealed electricity submeters. Each individual residential unit is electrically submetered and invoices are sent for the electricity that is consumed by that unit (as recorded by the submeter). That is what is meant by moving or converting a multi-residential building from bulk metered to a pay-per-use model of electricity billing.
