## **OEB Proceedings:**

The Consumers Council of Canada has participated in numerous OEB proceedings over the last 12 months. We have never been denied intervenor status.

## **Issues:**

The Consumers Council of Canada represents residential consumers. Residential consumers are materially impacted by the outcome of this proceeding as they pay the natural gas rates that fund demand side management programs. Residential customers are also participants in DSM programs. The Council will focus on all issues that impact residential consumers including the design of the programs, the cost of the programs, administrative costs, shareholder incentives, targets, cost-effectiveness tests etc.
