Re: EB-2024-0216 - Chatham x Lakeshore 2025-2029 - Cost Claim

We are counsel to the School Energy Coalition ("SEC"). Attached, please find the cost claim using the OEB's cost claim system.

SEC divided up responsibility amongst its consultant Jane Scott and counsel, Mark Rubenstein. Mr. Rubenstein was primarily responsible for the discovery process, and overall strategic direction and oversight. As a result of the scheduling issues with another OEB matter, Ms. Scott handled the settlement process.

For purposes of cost claim categorization, where dockets include both reviewing evidence and preparing interrogatories, or reviewing interrogatory responses and preparing for the Settlement Conference, we have allocated 50% to each specific category activity. As a practical matter, each set of activities are done at the same time and so cannot be readily extricable (e.g. we are preparing IRs as we review the evidence).

SEC submits that its participation in this proceeding was thorough and valuable and was designed to maximize its assistance to the OEB in this matter. SEC therefore requests reimbursement of its reasonably incurred costs as set out in this letter and supported by the attached information, which is commensurate with the scope of the issues.
