**Re: EB-2024-0319 – Hydro One Networks Inc. – Waasigan – Expropriation**

We are counsel to Hydro One Networks Inc. (“Hydro One”) and writing to provide the Board with two updates concerning the above-referenced application.

First, Hydro One has now been able to reach voluntary land acquisition agreements with the owners of four properties listed in Appendix 4 of the application. The four properties are identified in Appendix 4 as: TB128, TB96, AT18, and TB58. Given these circumstances, Hydro One no longer requests expropriation authorization in respect of these four properties. Hydro One is also continuing its efforts to negotiate additional voluntary land acquisition agreements with other property owners listed in Appendix 4. In order to reflect any additional successful negotiations, and subject to the Board’s views and directions, Hydro One proposes filing a revised version of Appendix 4, as a preliminary matter, if any public hearing into the application is determined to be necessary.

Second, Hydro One confirms it has substantively fulfilled the Directions set out in the Board’s letter dated December 2, 2024. In support of this conclusion, Hydro One has prepared the attached schedule which includes copies of all delivery slips that Hydro One received from its courier (CANPAR), Canada Post or other forms of confirmations (e.g. emails from landowners or from their authorized legal representatives). With the exception (a) one person who is listed as having registerable interest against the title to one affected property; and (b) the owners of one other affected property, Hydro One confirms that copies of the application materials were provided and received by all other affected persons prior to January 1, 2025.

[REDACTED], is listed as having an interest registered against the title to PIN 62321-0168, map reference TB60. Based on discussions held with the property owners, [REDACTED] registered interest concerned a historical loan that the property owners repaid in full, but no steps were taken to discharge [REDACTED] registrable interest. To complicate matters, Hydro One also understands that [REDACTED] is now deceased and Hydro One has no information regarding the executors of his estate. In view of these circumstances, Hydro One submits that

no prejudice would be caused to [REDACTED] by the application proceeding forward without further notification attempts or a substituted process.

Regarding the second noted exception, neither CANPAR nor Canada Post can locate a delivery slip for the property owned by [REDACTED]. Delivery was attempted but the package was then held by Canada Post awaiting pick up for 3 weeks and then returned to Hydro One. As the Board is aware, the [REDACTED] are, however, active participants in this proceeding and have sought intervener status which is unopposed by Hydro One. Given these circumstances, Hydro One submits the [REDACTED] intervention demonstrates direct knowledge of the application and thus achieving the objectives intended by the Board's December 2, 2024 Directions.

As the enclosed schedule contains landowner personal information, Hydro One is filing this schedule confidentially and proposes to prepare a redacted version of this schedule and file it electronically so that it may be accessed through the Board's electronic document repository for this proceeding. We expect the redacted version of this schedule will be filed by end of day Friday, January 31, 2025.
