


**Route Aerial Map**

Copy of an Order-in-Council approved by Her Honour the Lieutenant Governor, dated the 25th day of August, A. D. 1976.

Upon the recommendation of the Honourable the Minister of Energy, the Committee of Council advise that Ontario Hydro be authorized pursuant to Section 24 of The Power Corporation Act, R.S.O. 1970, Chapter 354, as amended,

- (a) to acquire by purchase, lease or in any other manner, or without the consent of the owner thereof to enter upon, take possession of, expropriate and use the lands described in Schedule I hereto, useful for, or capable of being used or made useful for transmitting, transforming and distributing power; and to have and hold the said lands however acquired or obtained, and develop, use, maintain, operate and improve the said lands for any of the purposes of the Act; and
- (b) to construct, maintain, operate, acquire by purchase, lease or otherwise, and use on the said lands erections, machinery, plant and other works and appliances for the transmission, transformation, supply and distribution of power, conduct, store, transmit, transform and supply such power for the purposes of the Act, and with lines of wires, poles, conduits, pipes, motors, transformers or other conductors, equipment or devices, receive, conduct, convey, transmit, transform, distribute, or supply such

power to or from or for any person at any place, through, over, under, along, upon or across any land, public highway or public place, stream, water, watercourse, bridge, viaduct or railway, and through, over, upon or under the land of any person.
