NOTICE OF APPLICATION AND NOTICE OF WRITTEN HEARING ELECTRICITY WHOLESALE

The following applicants have applied to the Ontario Energy Board for electricity wholesale licences. The applications will be decided by the Special Advisor, Market Operations who has been delegated this authority pursuant to section 6 of the Ontario Energy Board Act, 1998. The Special Advisor does not intend to provide for an award of costs when deciding these applications.

How to participate in the hearing

The applications will be decided by way of written hearings unless a party satisfies the Board that there is good reason for holding oral hearings. If you object to a written hearing for any of these applications, you must provide written reasons why an oral hearing is necessary.

If you wish to participate in a written hearing, you must forward three paper copies, and if possible, an electronic copy in Word format and searchable PDF format, of your written submissions to the Board and one copy to the applicant. All submissions must be received no later than 21 days after the publication date of this Notice.

All submissions must quote the relevant file number, and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.

Information relating to the applications is available for viewing at the Board's offices at the address provided below or by contacting the applicants. Addresses and contact information for the applicants are available on the Board's website.
