**Re: Enbridge Gas Inc. ("EGI")
2024 Annual Update to 5 Year Gas Supply Plan
Board File No.: EB-2024-0067**

We are counsel to Three Fires Group Inc. ("**TFG**") and Minogi Corp. ("**Minogi**") in the above-noted proceeding (the "**Proceeding**"). Pursuant to the Board's Notice of Hearing dated January 24, 2025, please find attached the cost claims of TFG and Minogi in the Proceeding.

Submissions. TFG and Minogi respectfully request an award of 100% of their eligible costs, given their strategic, cost-effective and principled participation in the Proceeding, reflecting the unique interests of Chippewas of Kettle and Stony Point First Nation ("**CKSPFN**") and Mississaugas of Scugog Island First Nation ("**MSIFN**") and their respective members. TFG and Minogi submit that this request is supported by the following considerations:

- (i) TFG and Minogi participated effectively in the Proceeding, taking a surgical, principled, and coordinated approach to matters related to the rights and concerns of CKSPFN and MSIFN and assisted in contributing to the Board's better understanding of such concerns and matters;
- (ii) TFG and Minogi ensured that their participation in the Proceeding was focused on material issues and consistent with the scope of their joint intervention, as set out in the joint Notice of Intervention;
- (iii) TFG and Minogi coordinated significantly to participate cost-effectively in order to limit overlap and efficiently advance issues of mutual interest and have confidence that the Board and EGI fully appreciate the significant reduction in costs achieved by TFG and Minogi through their joint intervention; and
- (iv) TFG and Minogi participated responsibly to avoid overlap, maximize efficiency, and ensure that their joint participation was not unduly repetitive and was focused on relevant and material issues.

We trust that this approach has maximized the efficient use of resources and the right of otherwise unrepresented and important Indigenous energy stakeholders to be heard in a manner that is consistent with the Board's mandate and statutory objectives.

TFG and Minogi respectfully request a full award of eligible costs.
