Re: OEB File: EB-2024-0059 - Wellington North Power Inc. 2025 Price Cap IR Distribution Rate Application

On February 26, 2025, the Ontario Energy Board (OEB) provided Wellington North Power Inc., the Applicant in the above noted proceeding, with a draft Decision and Rate Order.

Wellington North Power Inc. (WNP) has reviewed the draft OEB's Decision and Rate Order and, by way of this letter, request two changes to be made:

- 1. In section "7. Group 1 Deferral and Variance Accounts" (page 9) the monthly GA and CBR Class B amounts of \$14.54 and \$13.92 need to be updated to \$14.49 and \$13.89, respectively.
- 2. In section "7. Group 1 Deferral and Variance Accounts" (page 9), the GA and CBR Class B one-time charges also needs to be updated to \$173.88 and \$166.64, respectively.

Reason for change:

The amounts included in the draft Decision and Rate Order were taken from WNP's onetime request letter submitted on November 6, 2024. Since this date, the OEB has published

the "Q1 2025 Prescribed Accounting Interest Rate" which changed (reduced) the projected interest amounts for the period January 1, 2025 to April 30, 2025. In its letter to the OEB Registrar dated February 6, 2025, WNP confirmed it did apply the published Q1 2025 Prescribed Accounting Interest Rate of 3.64% to the interest amounts of the deferral and variance accounts. WNP confirms the Rate Generator model as provided with the draft Decision and Rate Order is correct and no changes are required.

Other than the required changes noted above, the Applicant confirms the draft OEB's Decision and Rate Order, as provided, is accurate, correct and no additional amendments are required.
