**Application to change its natural gas rates and other
charges beginning January 1, 2024**

**PROCEDURAL ORDER NO. 11
March 4, 2025**

The Ontario Energy Board (OEB) acknowledges the March 3, 2025, letter from Commissioner Zlahtic recusing himself from further participation in this proceeding.

The remaining Commissioners on the panel intend to continue hearing the proceeding as a panel of four.

The OEB is making provision for parties to advise if they have any concerns with this approach.

THE ONTARIO ENERGY BOARD ORDERS THAT:

1. If any party has concerns with the remaining four Commissioners on the panel continuing to hear the proceeding, it shall advise the OEB in writing, with a copy to all other parties, by **March 11, 2025**.
