RE: EB-2024-0198 Enbridge Gas 2026-2030 DSM Application Response of CCMBC to the OEB Procedural Order No.1

In Procedural Order No. 1 of March 4, 2025, the OEB made several findings and requests of CCMBC. This letter explains how CCMBC is complying with these findings and requests.

"The OEB finds that CCMBC and CME's interventions should be coordinated, as described above, because both represent the interests of manufacturers and other businesses. The OEB notes that there are inherently different views amongst other categories of interests as well, but representatives of these customers must work to pull together and express common viewpoints. The OEB is of the view that allowing both entities the ability to provide separate submissions should address concerns about different proposed solutions to issues. To the extent that CCMBC and CME find that they are unable to coordinate their interrogatory requests and participation at the technical conference and oral hearing, they are free to provide an explanation at the cost award stage."

CCMBC and CME have agreed to coordinate the preparation of interrogatories by exchanging draft interrogatories to avoid any duplication and are currently considering filing combined interrogatories. CCMBC and CME have also agreed to coordinate participation in the technical conference and oral hearing where one person will ask questions on behalf of both parties.

"The OEB also requests that CCMBC update its 2025 frequent intervenor form to provide further clarity on how its consultants participating in OEB proceedings receive direction from the Board of Directors and Management Team, including the frequency

of this direction. The OEB would also appreciate a list of the current Board of Directors, management team and member organizations."

CCMBC has reviewed the frequent intervenor forms of other intervenors to see how they provided this information. Most intervenors did not provide any information on how their representatives receive instructions from their Board of Directors or Management Team. However, as requested CCMBC will update its frequent intervenor form to include this information.

The OEB asked that CCMBC provide lists of its current Board of Directors and its management team. None of the intervenors provided the names of their directors or management team in the frequent intervenor forms. CCMBC does not understand why the OEB only wants this information from CCMBC and not from any other intervenor. If this information is required by the OEB it should be provided by all intervenors. CCMBC is providing the lists of its Board of Directors and its Executive Team with the expectation that other intervenors will also be asked by the OEB to provide their lists
