Your application is currently incomplete and cannot be processed until the following has been filed:

 Confirmation that you are applying for a licence amendment to include the additional facilities on the currently held licence.

Based on a review of the documents provided, please note that new licence applications are not required. 6732976 Canada Incorporated O/A Pod Generating Group ("Pod") is already licensed as a Standard Offer Program participant holding Electricity Generation Licence EG-2007-0684. The Ontario Energy Board does not licence facilities but rather the persons or companies that own and/or operate the facilities.

The applications submitted suggest the addition of five facilities to be owned and operated by Pod. In order to include these additional facilities on Pod's current licence, the correct process is to apply for a licence amendment under *Section 74 of the Ontario Energy Board Act, 1998*. Please confirm that Pod requests that the subject facilities be included in Schedule 1 of Pod's current generator licence.
