**Re: Application for an Amendment to Ontario Power Generation Inc.'s ("OPG")
Electricity Generation Licence EG-2023-0231**

OPG is applying to the Ontario Energy Board ("OEB") for an amendment to its Electricity Generation Licence EG-2023-0231 (the "Application") to comply with changes introduced by the IESO's Market Renewal Program ("MRP") scheduled to come into effect on May 1, 2025. The proposed amendment addresses the discontinuation of the existing Day Ahead Commitment Process and the introduction of a financially binding Day-Ahead Market.

OPG proposes to amend Part 8 (1) of its licence as follows.

Currently:

Subject to any applicable regulatory or safety requirements and the Agreement described in paragraph 2, the Licensee shall at all times offer all available generating capacity into the IESO administered markets for Operating Reserve, the Day Ahead Commitment Process and for real-time Energy (the Must-Offer Condition).

Proposed:

Subject to any applicable regulatory or safety requirements and the Agreement described in paragraph 2, the Licensee shall at all times offer all available generating capacity into the IESO administered Day-Ahead Market and Real-Time Market ~~markets~~ for Operating Reserve, ~~the Day Ahead Commitment Process~~ and for real-time Physical Transactions of Energy (the "Must-Offer Condition").

In addition, OPG proposes to correct a typographical error found in Schedule 1 of its licence. Licenced Facility #4 "Atikoken" should be "Atikokan".

OPG provides the following updates to information previously provided to the OEB in OPG's application to renew its electricity generation licence (EB-2023-0231).
